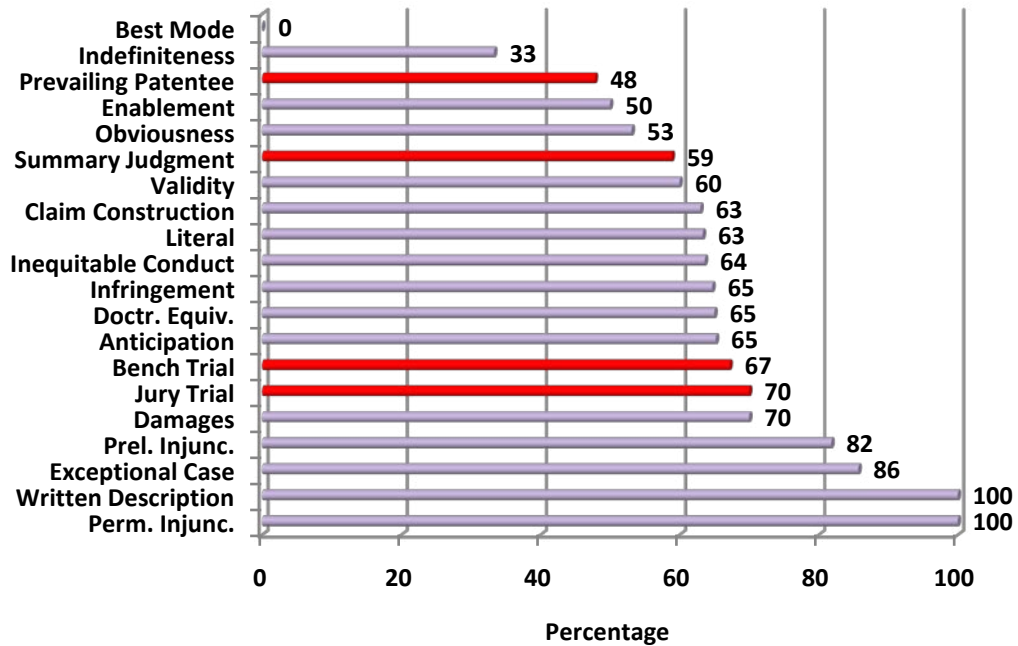

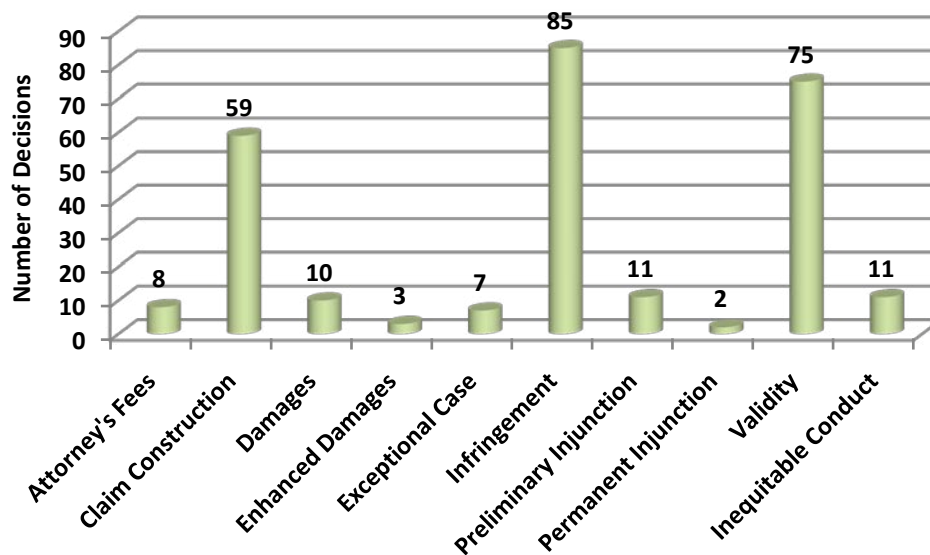

Judge Archer Affirmance Rates



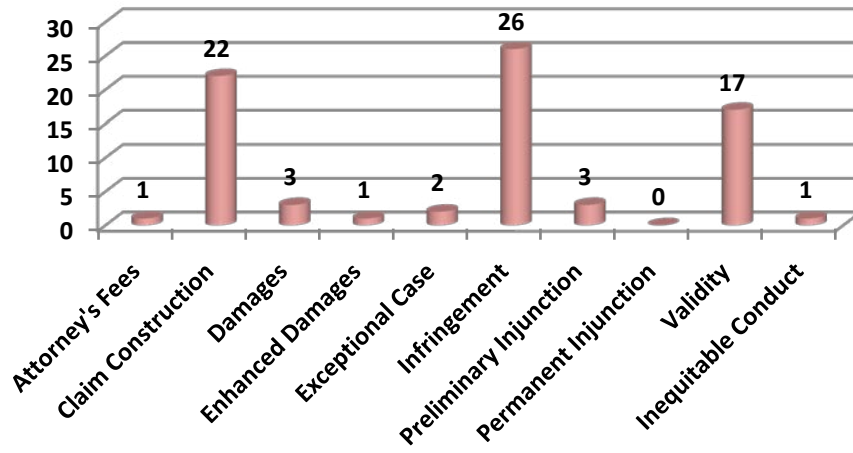
The number of decisions, by issue, for Judge Archer is shown below.

Decisions by Issue, Judge Archer



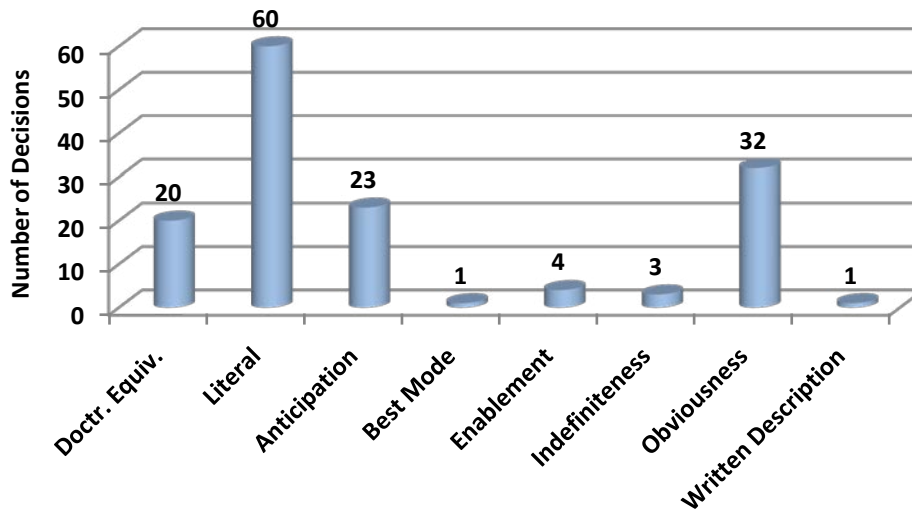
The number of opinions authored by Judge Archer, by issue, is shown below:

Opinions by Issue, Judge Archer



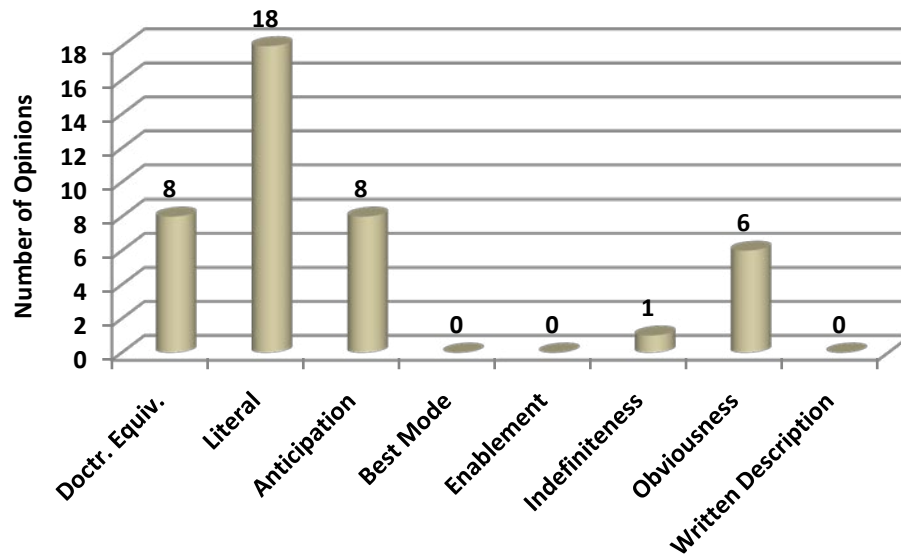
The number of decisions on various infringement and validity issues by Judge Archer is shown below:
