

**Arizona**

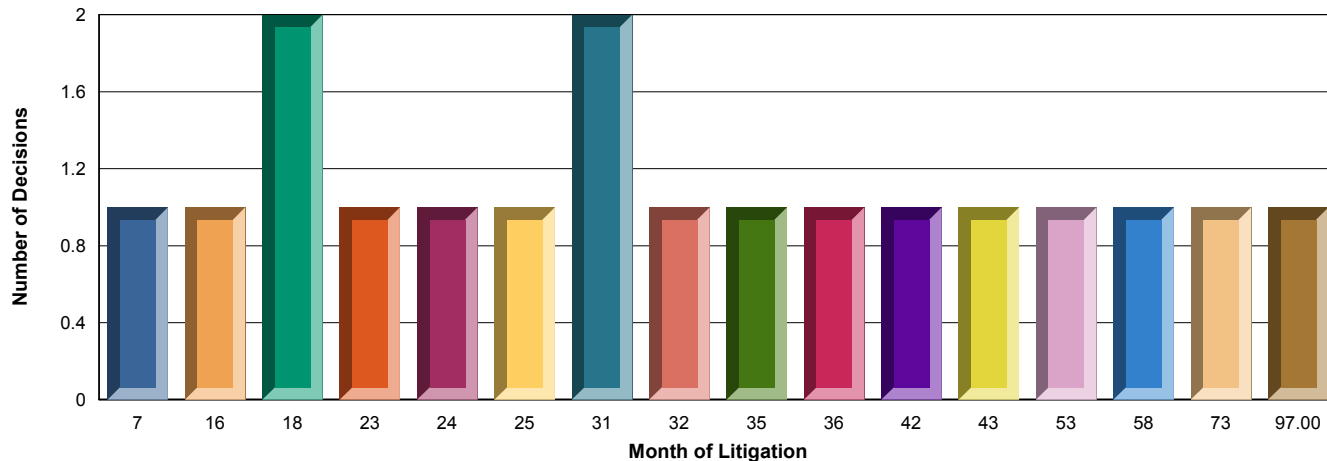
The dockets of patent cases in Arizona were examined to identify Markman rulings. The number of rulings found are as follows:
