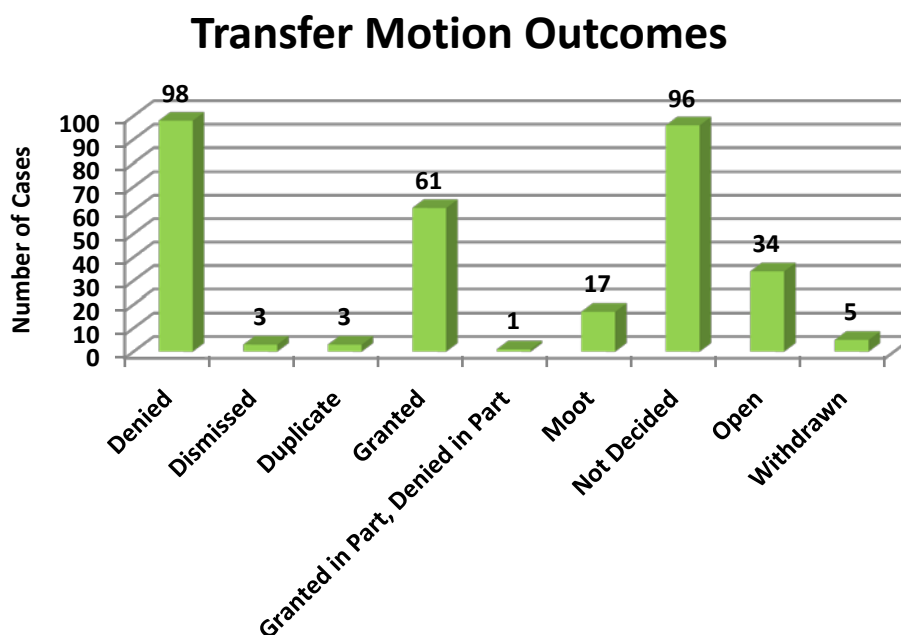

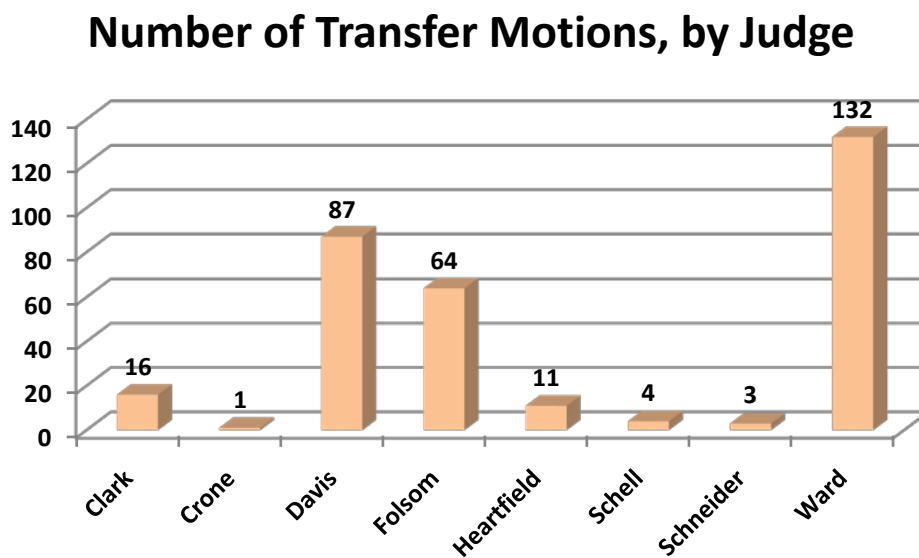
## Cases with Transfer Activity—By Active Judge

Of the 318 transfer motions, 98 were denied, 17 were moot, 3 were dismissed, 3 were duplicates of motions filed in other cases, 61 were granted (10 uncontested), 1 was granted in part, denied in part,<sup>1</sup> 96 were not decided, 34 are open, and 5 were withdrawn.

The transfer motion figures are illustrated in the chart below.

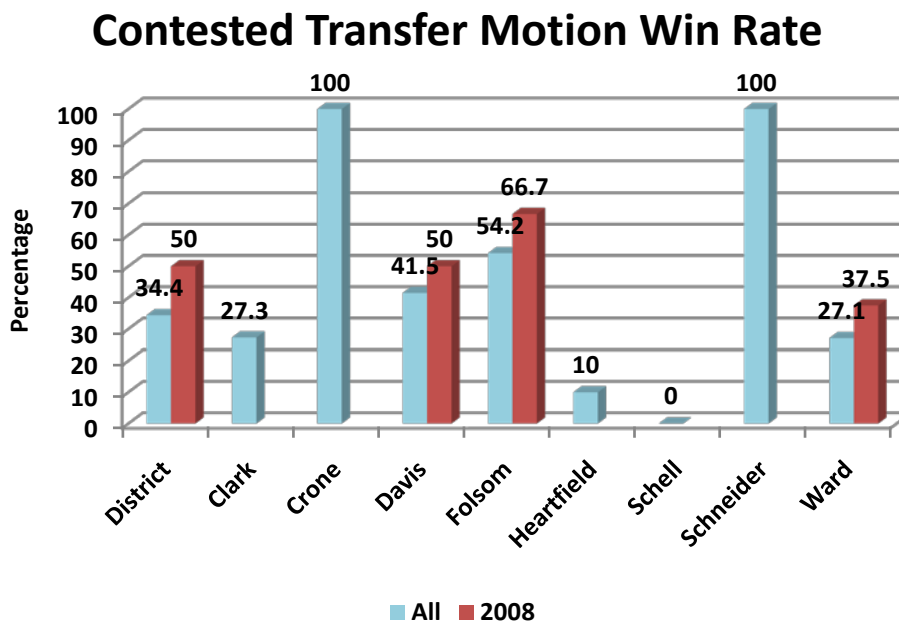


The number of motions for transfer, by judge, is illustrated below:

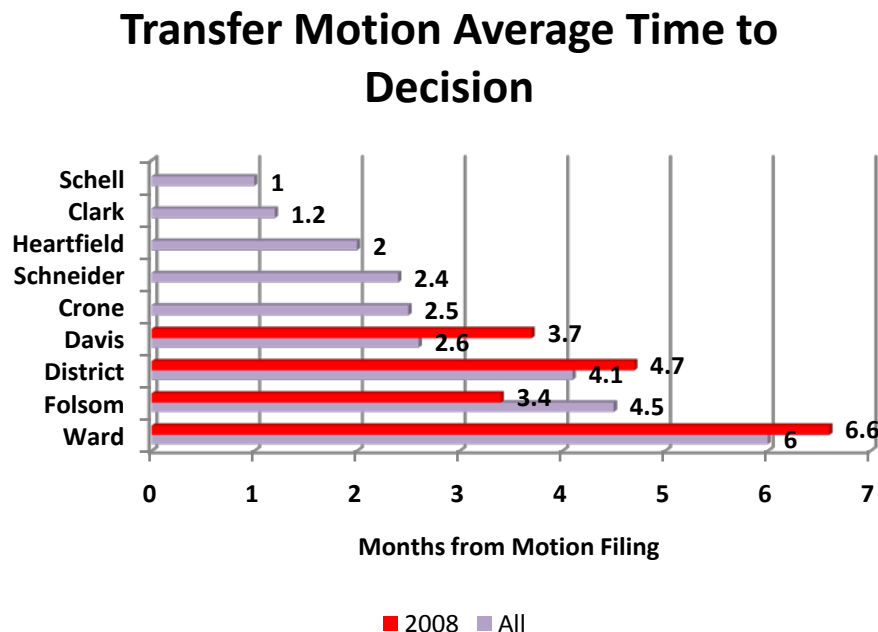


<sup>1</sup> A ruling granting a motion in part and denying it in part is treated as two rulings—one granting a motion and one denying a motion.

The contested win rates (excluding consent rulings) for these motions for transfer are as follows: Contested win rate: 34.4% (52 of 151). The defendant's win rate on its motions was 32.1% (45 of 140). The plaintiff's win rate on its motions was 75.0% (6 of 8). Although the number of decisions is relatively small, it appears that the win rate on transfer motions in 2008 has increased over the long-term average for the district as a whole, and for Judges Davis, Folsom, and Ward. 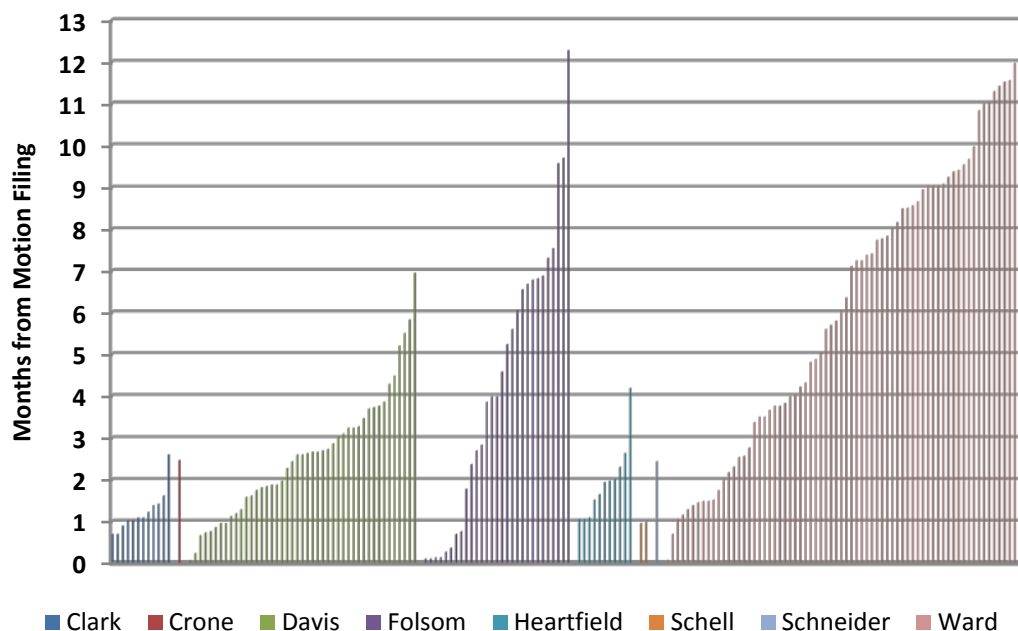


The average time from motion filing to decision was 4.1 months. In 2008 to date, the average time to decision on these motions increased for the district and Judges Davis and Ward, but decreased for Judge Folsom. The average time from motion filing to decision by judge for these motions to transfer is illustrated below:



The variation in time to decision is illustrated below. In the chart below, each line represents a transfer motion decision and the length of the line represents the time from motion filing to decision on the motion. Of the judges with a significant number of patent cases, Judge Clark is much faster to decide these motions, followed by Judge Davis. Judge Folsom has a substantial fraction of motions which took over six months to decide, while Judge Ward has a substantial fraction which took over nine months to decide.
