Total Denied: 9 Plaintiff Denied: 0 Defendant Denied: 9

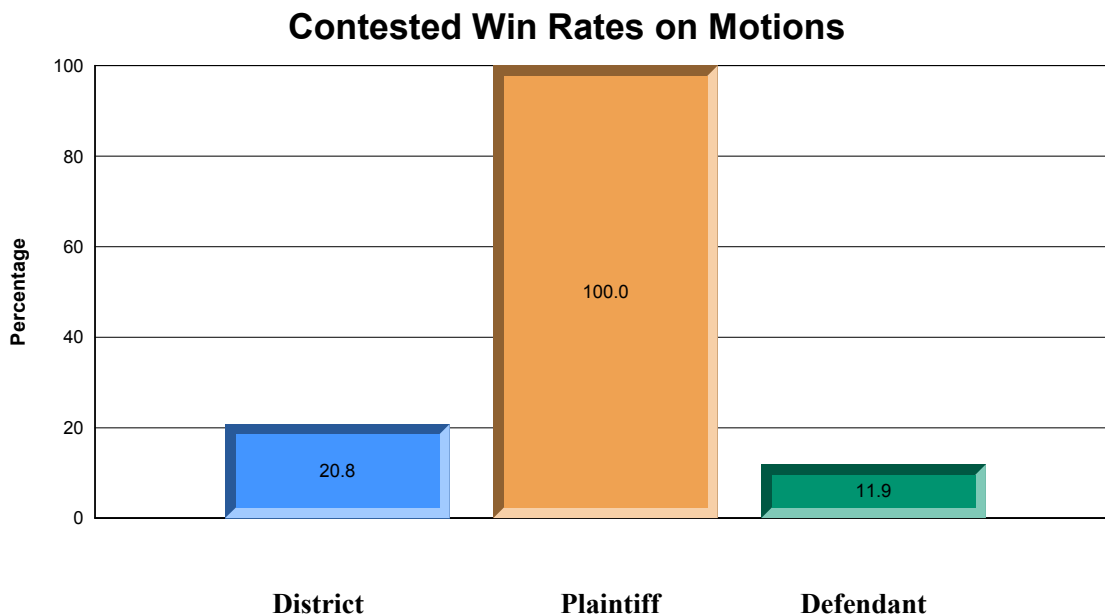

Defendant Win Rate: 11.9%

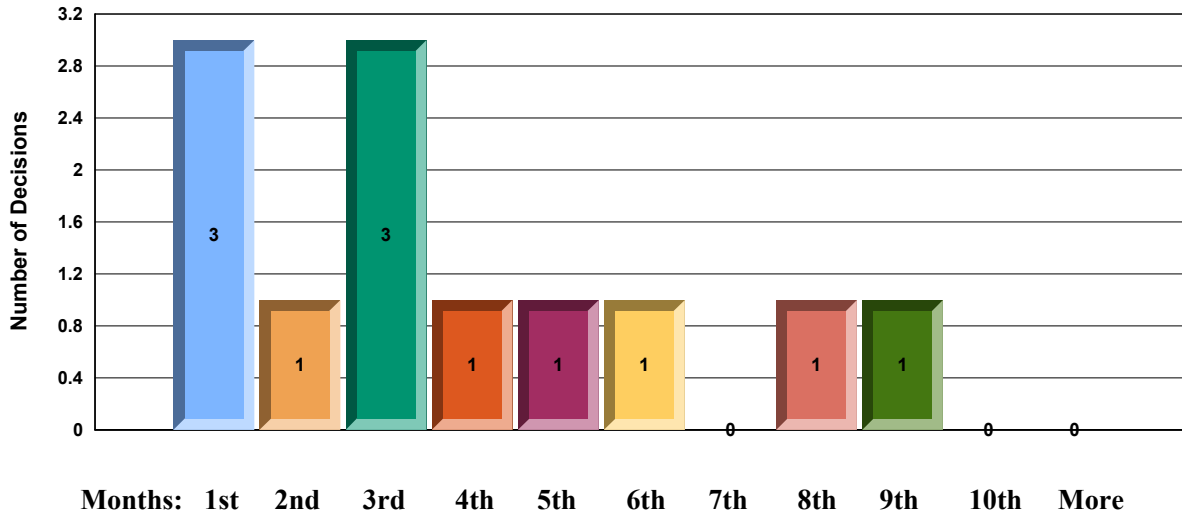
Overall Win Rate: 20.8%

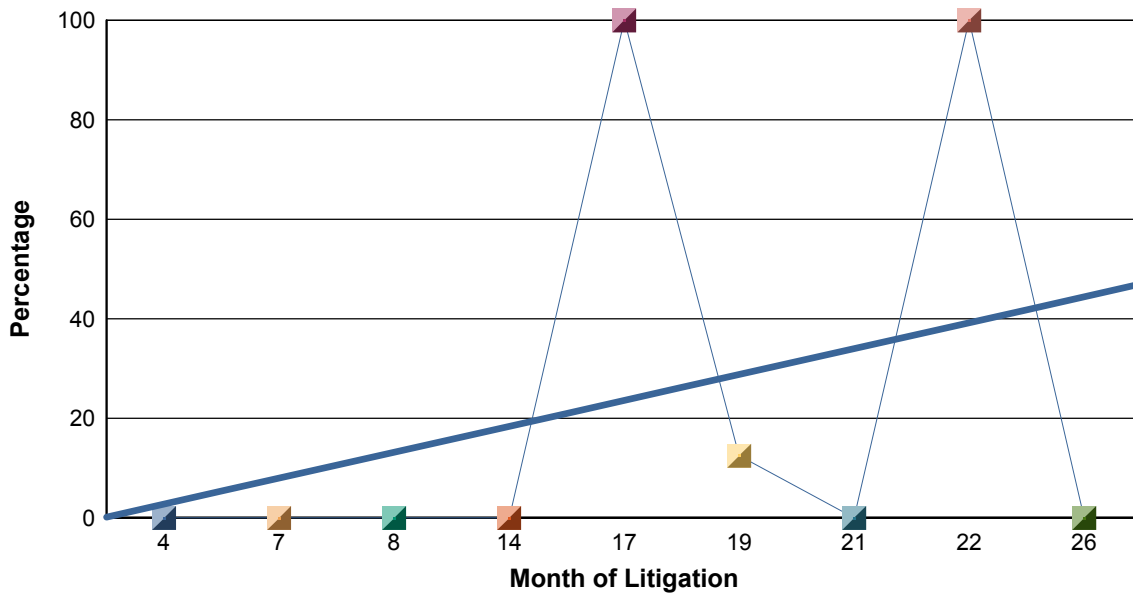


Win Rates as a Function of Month of Litigation:
