



Overview:

The times from case filing to trial (in months) for the districts identified below were determined by examining the dockets of patent cases in those districts. All trials in these districts that were begun are included in the figures in this report whether or not the trial resulted in a verdict. Other hearings, such as Markman hearings, are not included. For comparison purposes, the average time to trial for the period from the earliest trial found to 2010 is shown below, along with the average time to trial from 2000 to 2010, the average time to trial from 2005 to 2010, and the average time to trial from 2007 to 2010.



The variation in average time to trial for each year in which a trial was started is shown below.
